"TEAM PPQ GARAGE TRIVIA" Competition Terms & Conditions

- 1. The Promoter is Publicis Red Lion Pty Limited Trading as Publicis Personalised Plates ABN 12 098 273 539 of Level 2, 99 Melbourne St, South Brisbane, Qld 4101 ("Promoter" or "PPQ").
- 2. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 3. Entry is only open to residents of Queensland, aged 18 years or over with a valid Queensland Department of Transport and Main Roads CRN (Queensland driver's licence number).
- 4. Promotion commences at 8:00AM AEST on 05/07/2024 and ends at 3:00PM AEST on 07/07/2024 (total "Promotional Period").
- 5. Individuals can enter competition by visiting the TEAM PPQ stand at the Matt Stone Racing (MSR) garage at the NTI Townsville 500 and playing PPQ's GARAGE TRIVIA competition on supplied iPad's during the following times:
 - a. Friday 5th and Saturday 6th July 2024: 8am-5pm AEST.
 - b. Sunday 7th July: 8am 2.50pm AEST.
- 6. To enter the GARAGE TRIVIA competition, individuals must use the supplied iPad's to input all mandatory details (including first name, last name, valid email address, phone number), agree to terms and conditions, and complete the ten (10) trivia questions.
- 7. The prize consists of one (1) MAJOR PRIZE and twenty (20) DAILY PRIZES over the Promotional Period.
- 8. MAJOR PRIZE, total value \$4,845 including GST, consists of the following:
 - a. Cameron Hill's TEAM PPQ race suit that he wore at the 2024 NTI Townsville 500. Race suit will be professionally cleaned after the race. It will be posted to winner in the following weeks after the event at no cost to the winner. Value \$2,750 including GST.
 - b. Hot lap experience at MSR ride day at Queensland Raceway, Willowbank, QLD, for two (2) people on 26th November day (one hot lap each person). Time to be confirmed. Value \$1,600 including GST. Winner is responsible for all ancillary costs associated with attending, such as transport, accommodation etc.
 - c. One Personalised Plates Queensland Gift Voucher valued at \$495.
- 9. DAILY PRIZES consist of the following:
 - a. To take place on Saturday 6th July:
 - i. The first top scoring GARAGE TRIVIA winner from entries on Friday 5th July to receive a grid walk, pit tour and fly on the wall experience at the MSR Garage for two (2) people. Value \$1,600 including GST. Fly on wall experience is a money can't buy experience.
 - ii. After the top scoring daily winner is removed, the following nine (9) top scoring GARAGE TRIVIA winners from entries on Friday 5th July to receive a pit tour at the MSR Garage for two (2) people. Each prize value is \$1,000 including GST.
 - b. To take place on Sunday 7th July:
 - i. The first top scoring GARAGE TRIVIA winner from entries on Saturday 6th July to receive a grid walk, pit tour and fly on the wall experience at the MSR Garage for two (2) people. Value \$1,600 including GST. Fly on wall experience is a money can't buy experience.
 - ii. After the top scoring daily winner is removed, the following nine (9) top scoring GARAGE TRIVIA winners from entries on Saturday 6th July to receive a pit tour at the MSR Garage for two (2) people. Each prize value is \$1,000 including GST.
- 10. This is a game of skill. Each entry will be individually judged, based upon scoring system of GARAGE TRIVIA which is automatically applied to answers when entering. Points allocation is determined by PPQ and are detailed in Clause 11 of these terms. The daily prize winners will be chosen from the top scoring GARAGE TRIVIA entrants from the day prior. The major prize winner will be chosen from the top scoring GARAGE TRIVIA entrants through the total Promotional Period. Should the top scores be the same for any prize, these



- entrants will enter a top scorers draw, and the winner(s) will be selected by random computer selection at the MSR Garage Townsville 500 which is the only part of this competition that based on chance.
- 11. The ten (10) questions that form part of the GARAGE TRIVIA competition are shown below with the associated points allocated to each question. A total of 20 points is the maximum point score.

Q2: Name the two brothers who formed Stone Brothers Racing?	2 POINTS
Q3: Name the suburb, city and state where Matt Stone Racing is located.	3 POINTS
Q4: What year was the first Townsville Street Race held?	1 POINT
Q5: What city and state/territory does Cameron Hill reside in?	2 POINTS
Q6: What is team name for Cameron Hill's Supercar, at this year's Townsville 500?	2 POINTS
Q7: What is the Personalised Plate combination on Cameron Hill's Supercar at this year's Townsville 500?	2 POINTS
Q8: What are the maximum number of letters / numbers you can have on a Personalised in Queensland?	1 POINT
Q9: Name the winners of the Saturday and Sunday races at the 2009 inaugural Townsville race.	4 POINTS
Q10: What position is Matt Stone Racing sitting at in the PIRTEK Pit Stop challenge (before Townsville!)	1 POINT

- 12. Daily prize winners remain in the entrants' pool for their chance to win the major prize.
- 13. MAJOR PRIZE winner be drawn at the MSR garage on Sunday 7th July at 3.00PM AEST ("Prize Draw Date") and will be notified by mobile phone and text message on the number provided at entry between 3.00PM and 3.30PM. If MAJOR PRIZE is not claimed by responding to the phone call or text message or the entry is deemed as invalid by 3.45PM AEST on the 7th July 2024, a subsequent major prize winner being the next top scorer in line will be notified between 3.46PM and 4.00PM AEST on 7th July 2024 at the same place as the original draw.
- 14. DAILY PRIZE winners will be drawn at the MSR garage on both Friday 5th July and Saturday 6th July between 4pm-5pm for their prize experiences to be taken up the following day. Daily prize winners will be notified by mobile phone call and text message between 4.00-5.00pm AEST the day before and details will be given at



that time on when their respective pit tour/ grid walk/fly on the wall experience will take place the following day. Daily prize winners must confirm the names of the two (2) persons attending their prize experience within 15 minutes of receiving the phone call or text message via the same PPQ mobile number that contacted them. If daily prize is not claimed by responding to the phone call or text message or the entry is deemed as invalid within 15 minutes of the original call or text message from PPQ on each day of the daily prize draws, subsequent daily prize winner(s) being the next top scorer(s) in line will be notified until all nine daily prize winners have confirmed acceptance of their prize.

- 15. If any daily prize winner decides they cannot attend their prize experience, after they accept the prize, they must advise PPQ as soon as possible on the same mobile phone number.
- 16. One entry per day for DAILY PRIZES only on Friday 5th and Saturday 6th July only is accepted. Entering both on the Friday 5th and Saturday 6th is encouraged. However, daily prize winners cannot be duplicated and therefore cannot attend an experience more than once.
- 17. MAJOR PRIZE entries will be deduplicated to ensure only one (1) valid entry per email address and mobile phone number. The highest score entry will be kept as the entry for the major prize.
- 18. An individual entrant can only use one email address at any given time. Multiple email addresses and entries per individual entrant will not be accepted and the entrant will be excluded from the participation in the competition. Each entry must have a unique first name, last name, email address, phone number and image (if submitted) to be accepted.
- 19. Prizes are not transferable or exchangeable and cannot be taken as cash.
- 20. All winners are responsible for all ancillary costs not outlined in these terms and conditions as a result of redeeming all Prize elements and/ or travel costs, travel insurance and accommodation costs.
- 21. PPQ and the Prize supplier (Matt Stone Racing) reserves the right to determine, in their absolute discretion, the timing and length of any experiences forming part of a Prize.
- 22. The Personalised Plates Queensland gift voucher as part of the major prize must be used for redemption of a set of personalised plates. The personalised plate combination content selected by the winner (i.e. numbers and letters combined) ("Content"), is subject to availability and approval by PPQ. If no option for the final Content can be agreed on between PPQ and winner, PPQ will make the final determination as to the Content, and no correspondence will be entered into. Notwithstanding the above, the Personalised Plate Content must not be deemed by PPQ to be inappropriate as per Clause 23 (Obscene and inappropriate content). - 23. Plate combination cannot be deemed inappropriate. Obscene and inappropriate content includes but is not limited to:
 - a) Obscene or indecent combinations or captions.
 - b) Plates that are contrary to the public interest.
 - c) Plates likely to cause offence to a reasonable person.
 - d) Plates that may infringe a third party's rights or constitute false or misleading representation or conduct.
 - e) Plates promoting unsafe, violent or harmful behaviour, particularly on the roads, and Plates referencing weapons.
 - f) Plates promoting illegal drugs or criminal activity.
 - g) Plates that are propagandistic, discriminatory, or could offend a reasonable person or members or citizens of a distinct culture or a particular religion, nation, race, or minority status.
 - h) Plates that could be considered offensive to Government Departments.
 - i) Plates including content that may be defamatory, in breach of any laws, regulations, rules, codes or otherwise objectionable in the absolute discretion of PPQ.
 - j) Plate Content that infringes, or potentially infringes, any third party's rights including intellectual property rights and/or implies or falsely represents a connection with any third-party business.
 - k) Plates that create ambiguity in identification of a vehicle or enable mistaken recognition of a vehicle and/or its occupants.



- 24. Employees (and their immediate families) of the Promoter or Matt Stone Racing are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
- 25. If a prize is unavailable, for whatever reason, the Promoter, in its discretion, reserves the right to substitute the prize with a prize to the equal value and/or specification.
- 26. It is a condition of accepting a Prize that the winner must comply with all the conditions of use of the Prize and Prize supplier's requirements including Matt Stone Racing Corporate Ride Day <u>Terms and Conditions</u> and <u>2024 Conditions of Entry to Supercars Events.</u> Prize must be taken as stated and no compensation will be payable if a winner is unable to use the Prize as stated.
- 27. Total Prize pool value is \$26,045 (Inc. GST) based on recommended retail value by Prize supplier plus 'money-can't-buy' passes to the 'fly on the wall' experiences.
- 28. Entrants must only enter in their own name. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 29. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- 30. Entrants consent to PPQ using their name, likeness, image, video, plate story and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this Competition (including any outcome), and promoting any products manufactured, distributed and/or supplied by PPQ.
- 31. The Promoter's decision is final and no correspondence will be entered into.
- 32. The Promoter supports the responsible service and consumption of alcohol, and safe and enjoyable experiences for all participants. Some prizes may involve experiences or access to restricted areas, which require entrants to be sober and comply with relevant safety regulations. The Promoter reserves the right to refuse participation or prize fulfilment to any individual who appears to be intoxicated or behaving in an unsafe manner. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
- 34. As a condition of entering this Competition, each entrant licenses and grants the Promoter, its affiliates and sub-licensees a non-exclusive, royalty-free, perpetual, worldwide, irrevocable, and sub-licensable right to use, reproduce, modify, adapt, publish and display their entry (which shall include Content) for any purpose, including but not limited to future promotional, marketing or publicity purposes, in any media, without compensation, restriction on use, attribution or liability.
- 35. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all



liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of:

- a. any technical difficulties or equipment malfunction (whether or not under the Promoter's control);
- b. Any theft, unauthorised access or third party interference;
- c. Any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter;
- d. Any variation in prize value to that stated in these Terms and Conditions;
- e. Any tax liability incurred by a winner or entrant; or
- f. Faking and/or use of a prize.
- 36. The entrant agrees not to bring any claim or proceeding against PPQ (including its officers, employees, agents and Prize suppliers) for any damage, loss, injury or liability they may suffer in participating in this competition or otherwise connected with accepting and performing the Prize.
- 37. As a condition of accepting a Prize, the winner may be required to sign any legal documentation and in the form required by PPQ and/or Prize suppliers in their absolute discretion, including but not limited to a legal release and indemnity form or liability waiver.
